CALL TO ORDER: Mayor James Grogan called the meeting to order at 4:03 p.m.

ROLL CALL: Present were Mayor James Grogan, Councilmember Mike Sosebee, Councilmember Jason Power, Councilmember Caleb Phillips, Councilmember Angie Smith, City Attorney Dana Miles and City Clerk Bonnie Warne.

INVOCATION AND PLEDGE: Invocation and pledge was led by Mike Sosebee.

AGENDA: Motion to approve the agenda by: A. Smith/J. Power, carried unanimously in favor.

Planning Commission Member Vacancy: Motion to appoint Stan Worley to the Planning Commission by: A. Smith/J. Power. Vote carried unanimously in favor.

DDA Board Member Vacancy: Motion to appoint John Walden to the Downtown Development Authority by: C. Phillips/A. Smith. Vote carried unanimously in favor.

Surveying City Streets: The 4 quotes for surveying the street have been sent to the City engineer to review. Motion to table until the Nov. 2<sup>nd</sup> meeting by: A. Smith/C. Phillips. Vote carried unanimously in favor.

Animal Control: Mayor Grogan updated that the animal control discussion is still in process.

What to Paint the Water Tank: Mayor Grogan stated that 11 drawings have been submitted. Motion made to table decision until the Nov. 2<sup>nd</sup> meeting by: C. Phillips/A. Smith. Vote carried unanimously in favor.

Ratify Agreement with GMRC on Trails Grant: Motion to approve the mayor signing the agreement by: M. Sosebee/J. Power. Vote carried unanimously in favor.

Contracts: After discussion on the list of contracts, agreements, and leases, request to present those that end December 31<sup>st</sup> to the Nov. 2<sup>nd</sup> meeting. Motion made to bid the contract for solid waste/garbage for 2016 by: C. Phillips/A. Smith. Vote carried unanimously in favor.

GMA Health Insurance Cost: Mayor Grogan stated that the health insurance cost has increased. Motion for the City to pay 100% of employee insurance and 67% of family insurance by: C. Phillips/A. Smith. No change to the dental.

REPORTS: Mayor Grogan and Jason Power met with GMRC on the park and trail grant and found that it could take years to receive the grant monies, but we could start some of the interworking's. Angie Smith stated that the Family Connection's poverty simulation was attended well. The Mayor also reminded everyone that the Moonshine Festival event by Kare for Kids is this weekend and will have over 1000 cars in the car show.

ADJOURNMENT: With there being no further business to attend to the meeting closed and adjourned at 4:38 p.m. The motion carried unanimously; J. Power/M. Sosebee.






