We have new staff members who are eager to serve our community, staff that have taken on new roles, newly appointed officials that we expect to do great things for the City, and progress on several projects that I believe will truly impress.





A message from your City Manager ...

Happy New Year! It is our wish that you and yours had a wonderful holiday season and we wish you the very best in 2019.

Your city has a great deal going on and I wanted to give you a brief update on some of the activity underway or that should be expected in the immediate future:

- Main Street Park Phase I Construction continues but has been seriously hampered by rain. The rest room design is nearing completion as is the landscape plan and the destination playground has gone out to bid. We have also begun researching amphitheaters and their operation.
- Farmer's Market design and planning is nearing completion and should go out to bid this month. Work planned includes grading, parking, paving and concrete work, fencing, landscaping, a rest room and 50' X 150' shelter.
- Well #111 is online and working well, well #108 has been upgraded, warranty work is underway on the wireless water meters, and additional storage space for the maintenance facility has been designed and is out to bid.
- Sidewalk planning is underway for several new additions to our system.
- We have been live streaming City Council Meetings for several months; so, if you are interested but are unable to make it to City Hall, you can watch it live or a recorded version.

Our city has a lot of opportunity and a great deal to look forward to. As we work through the winter and look forward to the spring, your city continues efforts to better serve her citizens and make Dawsonville even better.
